- 1. Payment for all purchases is due STRICTLY on the 20th of the month following invoicing. Accounts that are still outstanding at the 30th of the Month following invoicing will be put on "Stop Credit". Repeat failure to adhere to the trading terms of Tile Shed Limited will result in the withdrawal of credit facilities.
- 2. Interest may be charged on overdue accounts.
- The whole of the amount of credit outstanding shall become immediately due and payable to Tile Shed Limited.
 a) At the discretion of Tile Shed Limited if the customer is in breach of these terms and conditions, or
 - b) Upon the termination of this contract by the customer pursuant to clause (4) herein.
- 4. The customer may close the account, provided that the whole sum owing, plus interest if applicable, previously incurred, be paid to Tile Shed Limited.
- 5. The Tile Shed Limited may amend the Terms and Conditions of this contract by giving the customer notice in writing. Full Terms and Conditions are listed on our website www.tileshed.co.nz/legal
- 6. The customer shall be liable for all costs of collection and legal fees incurred by Tile Shed Limited in recovering amounts payable hereunder.
- 7. Returned goods will not be accepted after fourteen (14) days from date of pick up. All products must be in a saleable condition. Only full boxes of tiles can be returned. A restocking fee of 50% plus freight will be charged on all returns.
- 8. All tiles and/or products remain the property of Tile Shed Limited until paid in full.
- 9. The use of this account shall constitute acceptance of these Terms and Conditions and has been supplied with a copy of this Agreement.
